Each year the symposium is well-attended by approximately 400 family law attorneys, law students and others interested in family law and this year was no exception.

Debra S. Frank has moderated the Recent Development panel for the last two years. She is a member of the Los Angeles County Bar Association Family Law Section Executive Committee and its Secretary, editor of its annual Family Law Symposium book, and a mediator for the Los Angeles County Bar Association Family Law section.
