"Stock options constitute community property to the extent they are attributable to services rendered during marriage and before the parties' separation, even if the options are exercisable at a later time," says Debra S. Frank. "To properly apportion separate and community interests in stock options, it is necessary to ascertain the periods of employment to which the options may properly be allocated. This requires an examination of the circumstances of the option grants to determine whether the options should be characterized as deferred compensation, incentives for future performance, or both."

Debra S. Frank advises her clients on the issues involved in dividing the different types of specialized forms of compensation. Ms. Frank also authored the chapter "Marital Agreements," that appeared in California Marital Settlement and Other Family Law Agreements, CEB (Continuing Education of the Bar California), looseleaf, last updated Spring 2009. Ms. Frank is the Vice Chair of the Los Angeles County Bar Association Family Law Section Executive Committee, editor of its annual Family Law Symposium book, mediator, and a founding member and Master of the Southern California Family Law Inn of Court.
